3.1 Salary Adjustments

The Executive Director is recommending a four step increase for John Hume, MRPC's Planning and Development Director; from \$66,190 (Grade 6/Step 5) to \$73,062 (Grade 6/Step 9). After the layoffs in

December 2014, Mr. Hume assumed the responsibility for the management of two Departments , Comprehensive Planning and Community Development. Mr. Hume has also been instrumental in obtaining a number of funding opportunities for the agency. This salary increase will also bring his salary in line with other Directors with a similar experience, education and management skills.

Brad Harris, Transportation Director will receive an annual merit payment of 2.0% (or \$1,767.36) in accordance with the vote by the Commission at its February 2014 meeting regarding employees who have reached their top step ("they will be eligible to receive annual compensation up to the most recent CPI increase for most recent year, five, or ten year span that data is available, funding available.)"

Discussion occurred regarding an email from Brad Harris, Transportation Director to the Executive Director indicating that he would not pursue a grievance at this time regarding his salary and offered alternative options regarding his salary.

Please note that the Executive Director and Administrative and Human resources Director will complete all salary market study tasks necessary for the presentation of a new pay scale no later than July 2016.

M. Pineo moved that the Montachusett Regional Planning Commission approve the salary adjustments as presented by the Executive Director effective July 1, 2016. The motion was seconded and passed unanimously.

3.2 FY17 Budget Approval

Mr. Eaton proposed the adoption of the FY17 budget for this agency. Please note the new format which has been prepared in accordance with our Auditor's request (Roland Lambalot, CPA). He explained the budget in detail adding a correction that equipment costs have increased due to the purchase of new computer hardware. The original estimated cost was \$33,462 and equipment costs are now at \$44,583. See handout.

M. Pineo moved that the Montachusett Regional Planning Commission approve the FY2017 budget as presented by the Executive Director with the amendment of the equipment purchase line item. The motion was seconded and passed unanimously.

Discussion also occurred regarding leasing of MRPC office space and MRPC overhead rates.
