Montachusett Metropolitan Planning Organization Endorsement of Amendment #2 to the FFY 2024-2028 Transportation Improvement Program

The Montachusett Metropolitan Planning Organization (MMPO) has completed its review of Amendment #2 to the Transit Element of the FFY 2024-2028 Transportation Improvement Program (TIP) in accordance with 23 CFR Part 450 Section 324 (Transportation Improvement Program: General) of the October 28, 1993 Final Rules for Statewide and Metropolitan Planning.

This Amendment to the FFY 2024-2028 TIP is financially constrained and conforms to the Montachusett 2024 Regional Transportation Plan. Based on the results of the review and analyses, the Montachusett 2024 Regional Transportation Plan and FFY 2024-2028 TIP are consistent with the air quality goals of, and in conformity with, the Massachusetts State Implementation Plan. This Amendment and TIP do not add or delete any regionally significant, non-exempt projects, nor reprogram any existing regionally significant, non-exempt projects across analysis years.

Therefore, the Committee of Signatories representing the Montachusett Metropolitan Planning Organization (MMPO) by a majority vote hereby endorses Amendment #2 to the FFY 2024 Transit Element of the Montachusett Region FFY 2024-2028 Transportation Improvement Program (TIP).

This endorsement is signed by the MassDOT Secretary and CEO, or their appointed designee, on behalf of the entire Montachusett MPO. This action is taken after an official vote of the MPO.

Based upon the Montachusett Metropolitan Planning Organization Public Participation Program (PPP) developed by the Montachusett Regional Planning Commission (MRPC) that attempts to establish a proactive public involvement process as required under the Metropolitan Planning Regulations, this memo serves as notice of a 21 day public review and comment period for Draft Transit Amendment #2 to the MPO Endorsed FFY 2024-2028 Montachusett Transportation Improvement Program (TIP) and the availability of the draft document developed by the Montachusett MPO. The public involvement process with the time established for review of the TIP and its Amendments will satisfy the Program of Projects (POP) requirements for transit projects. The public review and comment period will commence on Tuesday November 28, 2023 and close at the end of business on Monday December 18, 2023.

The Amendment reflects cost changes for two (2) projects, the addition of seven (7) projects and the removal of ten (10) projects in FFY 2024. At a meeting held on November 15, 2023, the Montachusett MPO reviewed the proposed Amendment and voted that it be released for public review and comment.

Comments received will be reviewed and incorporated into a final TIP Amendment #2.

If no significant objections are made during the public review period, the final document will be forwarded for endorsement to the MPO at a meeting to be held at 1:00 PM on Wednesday December 20, 2023.
