NOTE: Previously, \$70,600 of the total \$3,229,064 HPP award was transferred to the Federal Transit Administration (FTA) on August 26, 2008. Because of this transfer, the federal amount in this project amendment has been reduced to \$3,158,464. However, the Non-Federal Funds matching portion is required by FTA to remain at the matching level of \$807,266 for the original total HPP funding amount (\$3,299,064). Additionally, the Non-Federal Funds Amount of \$807,266 is proposed to be split 3 ways between the Town of Ayer, the Montachusett Regional Transit Authority (MART) and the state through a MassWorks grant (currently unawarded). The Town of Ayer and MART are both currently committed to their matching portions totaling \$263,205. MART has also committed to funding \$17,650 as the matching amount to the previously transferred \$70,600. MART and the Town of Ayer have committed to cover the remaining 1/3 of matching funds in the amount of \$263,205 should the state MassWorks grant not be awarded. Thus MART and the Town of Ayer have committed to meet the matching funds for this project.
